**Institutional Voids, Business Groups, and Peer-to-peer Lending**: The early part of my research career focused on corporate finance and the market failure theory of business groups. I studied the financial decisions of group-affiliated firms in emerging markets, revealing how business groups fill institutional voids. More recently, I have examined the role of private entrepreneurs, particularly women, in filling these voids through peer-to-peer lending.

**Microfinance, Gender, and Financial Inclusion**: My research has significantly advanced the understanding of microfinance, particularly its financial and social performance, and its role in financial intermediation and inclusion. I have explored issues such as the impact of gender and national culture on access to financial services, incorporating language as a cultural institution that influences the success of financial intermediaries in reaching out to women and supporting female entrepreneurship.

**Integrative Research Approach**: My research approach is integrative, combining financial methods with social, cultural, and organizational variables.
